Common Causes of Spinal Cord Injury The following are among the most common causes of spinal cord injury and may be grounds for a personal injury lawsuit:

- Auto Accidents – According to reports by the Centers for Disease Control, motor vehicle accidents are the leading cause of spinal cord injuries in Americans under the age of 65. If you suffered a spinal injury in an auto accident, you have rights – in the event of an auto accident, the party with the greater burden of fault is responsible for damages proportionate to his or her degree of fault, usually expressed as a percentage determined by the court.

- Falls – Accidents involving falls account for a large number of spinal cord injuries every year, and they cause the majority of spinal cord injuries in individuals over 65 years of age. If you or someone you love has suffered a spinal cord injury as a result of a fall, it may be possible to file a premises liability claim to obtain compensation for your suffering. - Striking and Being Struck by Objects – Sports injuries, recreational injuries, and accidents involving falling objects cause 18 percent of all spinal cord injuries, according to the CDC.
