In 2006, there were 88,000 injuries in the United States as a result of motorcycle accidents, and according to the National Highway Traffic Safety Administration (NHTSA), motorcyclists are 34 times more likely to be killed in a traffic collision than motorists in passenger vehicles. Because motorcycles offer no external protection in the event of a crash, motorcyclists are subjected to the full force of a collision. Even motorcyclists who wear proper riding gear face a real risk of suffering a traumatic brain injury or spinal cord injury in a motorcycle accident, in addition to broken bones, cuts, lacerations, and "road rash" or severe skin abrasion.

Common Causes of Motorcycle AccidentsUnfortunately, many motorcycle accidents result from the negligent actions of other motorists. - Driver inattentiveness
- Following a motorcyclist too closely
- Speeding or driving recklessly
- Attempting to share a lane with a motorcyclist
- Pulling into the path of a motorcyclist from a parking lot or driveway
- Making a left-hand turn in front of an oncoming motorcyclist
